STEP 1 Identify risks

Consider the following hazards:

- 1. Electrics
- 2. Gas Appliances
- 3. Hazardous Substances
- 4. Chemicals
- 5. Storage
- 6. Food hygiene
- 7. Computer Equipment
- 8. Lone Working
- 9. Fire Considered under Fire Risk Assessment and not considered here.

Being in a public building with access for unsupervised public use, there may be an increased level of risk due to lack of knowledge associated with the hazards above. Extra safety measures may be required.

A First Aid box is accessible at all times, and is regularly checked.

Weekly, monthly and annual checks are made of the buildings, car parks, grounds to check for any change in circumstances, deterioration of equipment etc.
